



## ST. RITA HARVEST FESTIVAL RAFFLE

### OFFICIAL RULES

1. This raffle is conducted by St. Rita School (“SR”) located at 322 N. Baldwin Ave., Sierra Madre, CA 91024. SR is a tax exempt organization organized as a religious educational institution under Section 501(c)(3) of the Internal Revenue Code (“IRC”) and as defined by California Revenue and Taxation Code Section 23701d. By purchasing a raffle ticket(s), participant agrees to be bound by these Official Rules.
2. The raffle will be conducted beginning on or about September 20, 2022 through October 22, 2022. Each raffle ticket has a detachable coupon or stub, and both the ticket and its associated coupon or stub are marked with a unique and matching identifier. Winners of the prize(s) are determined by draw from among the coupons or stubs that have been detached from all tickets sold for entry in the raffle.
3. The odds of winning are dependent on the number of valid raffle ticket entries. As an example, if 100 valid raffle tickets are sold, then the odds of winning a prize are 1:100. An individual may purchase as many raffle tickets as he or she may wish, subject to availability.
4. Purchasers must legibly write their name, address, phone number and email address (if applicable) on the raffle ticket.
5. If more than one name is listed on the raffle ticket, the first name listed shall be considered the entrant. SR shall, will and can have no obligation for delivery of any prize to any person other than the entrant. Minors may not purchase or have their names identified as entrants.
6. Payment for the raffle tickets shall be made in “good money” which may be cash (including cash equivalent) or check. Checks should be made payable to “St. Rita School.” In no event will raffle tickets be sold, traded or redeemed over the Internet. All purchases of raffle tickets are final and no refunds will be issued.
7. The winner(s) will be picked by random drawing to be held at 8:30 p.m. on Saturday October 22, 2022 at St. Rita School (West Campus). Winner(s) need not be present to win. Winner(s) will be contacted immediately after the drawing at the phone or email address provided on the raffle ticket. Winner(s) agree to allow the use of their name and/or likeness for publicity purposes without compensation.
8. The prizes in the raffle to be given away include:

**Grand Prize: \$10,000 Cash**

**Second Prize: \$2,500 Cash**

**Third Prize: \$1,000 Cash**

9. The winner(s) must present the raffle ticket stub when claiming their prize along with a picture identification. The winner(s) is subject to all Federal and State tax regulations and payment of any taxes is the sole responsibility of the winner(s). In accordance with IRS rules, backup withholding of 24% will be withheld on prizes over \$5,000. SR will file appropriate reports with the IRS and CA Franchise Tax Board as required by law.
10. If the winner(s) cannot be reached at the phone number or email address provided on the ticket stub for any reason by October 30 2022, a disqualification shall result and an alternate winner will be drawn.
11. Employees of SR and St. Rita Church, at their discretion, may participate in the raffle.
12. The decision of the Principal and Pastor of St. Rita School and Church shall be final on all matters concerning the raffle.
